
**PLAINTIFF MORI'S

COMES NOW, plaintiff Mori, through counsel, based on the following Points and Authorities, respectfully moves for disbursement of the balance of the dividends in escrow as follows:

POINTS AND AUTHORITIES

1. On May 13, 2013, the Trial Court issued its judgment adjudging the plaintiff as the legal owner of the remaining 720 shares at issue in this matter held by third party defendant, Marion Olter.
