Memorandum of Points and Authorities


1. This case has been scheduled for a status conference on May 15, 2013.
2. The FSM National Government and the Plaintiff met on May 9, 2013, with a view to resolving certain aspects of the case, especially, regarding the dollar value of the Plaintiff's claim. The discussions are ongoing and the parties require more time to obtain documents relevant to the case.

3. Both the FSM National Government and the Plaintiff have agreed to have the status conference date of May 15, 2013, continued until June 7, 2013, as counsel for the FSM National Government will be travelling off-island on May 13, 2013, and will not be back until May 28, 2013.
4. In view of the above, the FSM National Government with the consent of the Plaintiff request that this motion to continue the status conference date be granted.

MOTION TO FILE BY FACSIMILE
