Plaintiff, Federated States of Micronesia Development Bank ("FSMDB"), through its attorney of record, and Defendants Tulpe B Refelong and Mac P Refelong ("Defendants"), through their attorney of record, jointly request the entry of the Stipulated Order in Aid of Judgment, as set forth below.

The parties are in agreement that Plaintiff, FSM Development Bank ("FSMDB"), shall be entitled to an Order in Aid of Judgment, pursuant to 6 FSMC Section 1409 as follows:

1. Judgment was entered in favor of FSMDB and against Defendants on April 1, 2009, and that judgment has not been satisfied. The principal amount of the judgment shall continue to accrue statutory post-judgment interest at 9% per annum.

2. Defendants Mac P Refelong and Tulpe B Refelong shall pay to FSMDB the amount due beginning November 2012 until the judgment is satisfied, by installments of no less than \$ 150.00 per month.

3. The first payment shall be due on November 26, 2012, even if entry of this order occurs after November 26, 2012. Payments made thereafter shall be due monthly thereafter on the 25th of each month.


4. Payments shall be made directly to the FSM Development Bank, Kosrae Branch, PO Box 104, Tofol, Kosrae, FM 96944 or to FSM Development Bank, PO Box M, Kolonia, Pohnpei, FM 96941. Payments may also be made by deposit or by electronic fund transfer (EFT) to FSMDB's bank account as follows: Bank of Guam, Pohnpei Branch, account number 0209-031796, routing number 1214-05115. Defendants are responsible to ensure timely receipt of all payments by FSMDB by the 25th of each month. Defendants are requested to notify FSMDB of all deposits made to FSMDB's

bank account either by email to: noras@fsmdb.fm or by fax to 691-320-6533 or 691-320-2842, to ensure timely and proper credit of all payments made by Defendants to this judgment.

5. If Defendants Mac P Refelong or Tulpe B Refelong fail to comply with this Order and Plaintiff is required to take further action to enforce this Order, or to otherwise collect on the judgment, Defendants shall be responsible for Plaintiff's legal fees, and other costs necessary to compel compliance with this order as the Court may allow.


