**ORDER GRANTING SECOND
ENLARGEMENT AND SETTING
STATUS CONFERENCE**

On March 9, 2012, the Defendants represented by FSM Assistant Attorney General Danny Rescue, Jr. filed a Defendant's Dr. James Reese, Dr. Jamal Mustafa, and Canvasback Missions, Inc., Second Motion for Enlargement of Time and a Defendant's Motion to File by Facsimile. The motions request that the Defendants who filed the motion be given additional time to respond to the Plaintiff's Mongkeya et al. discovery requests. In support of their motion counsel for these Defendants' asserts that he has yet to receive complete answers to the discovery from all of his clients and that he is e-mailing them to encourage their complete responses.


Pursuant to FSM Civ. R. 6(d), counsel Rescue has attempted to contact the other counsel in this matter, but have only received acknowledgement and agreement from co-Defendant's counsel Snyder Simon, Esq., who represents the Kosrae State Government and Kosrae State Hospital.

After reviewing the motion and the file, the court finds sufficient cause to grant the subject Defendants' motion to file by FAX and motion for second enlargement. The discovery deadline in this matter is enlarged to April 30, 2012. The pre-trial motions deadline is now set for Wednesday, May 16, 2012.
