

ORDER GRANTING ENLARGEMENT
AND REVISING SCHEDULE

On April 5, 2013, the parties in this matter filed a Stipulated Motion for an Enlargement of Time. Marstella E. Jack, Esq. represents the Plaintiffs Mongkeya et al.. Kosrae State Attorney General Cindy Haro, Esq. represents the Defendants Kosrae State Hospital, the State of Kosrae (Kosrae), and Dr. Winston Likiaksa. FSM Assistant Attorney General Aaron Warren, Esq. represents the Defendants Dr. James Reese, Dr. Jamal Mustafa, and Canvasback Missions Inc.

The parties have met, conferred, and report that due to the fact that Defendants' counsel are relatively new to the case, the parties counsels' other scheduling commitments, and the need to reschedule certain depositions due to the unavailability of deponents, will prevent them from meeting the previous Court ordered pretrial schedule issued on February 28, 2013.

The Court finds sufficient cause for granting the stipulated motion for enlargement. The parties jointly recommend the following revised schedule. For the reasons set forth above the Court's pretrial deadlines shall be enlarged as follows:

1. All discovery shall be completed on or before May 31, 2013.


1 2. All pretrial motions shall be filed on or before June 14, 2013.

2 3. Responses to pretrial motions shall be filed on or before June 28, 2013.

3 If pretrial motions are filed, the Court shall hear arguments on the pretrial motions on
4 Tuesday, July 16, 2013 at 9:30 a.m. at the FSM Supreme Court in Tofol, Kosrae and following
5 the arguments on the pretrial motions, the Court will discuss the setting of a trial date with the
6 parties.

7 If no pretrial motions are filed, then trial will begin on Tuesday, July 16, 2013 at 9:30
8 a.m. at the FSM Supreme Court in Tofol, Kosrae. If trial is to take place, the parties shall meet
9 and confer on Monday, July 15, 2013 to label exhibits and if possible to stipulate to the
10 authenticity and/or admissibility of exhibits or other evidence to be submitted at trial.
